NOTICE 10/PPGL/UFSC/2024, October 10th, 2024.

Provides the rules for the selection process for new Master's and Doctorate students in the Postgraduate Program in Linguistics at UFSC, in the area of concentration in Sign Languages.

The Coordinator of the Postgraduate Program in Linguistics - Programa de Pós-Graduação em Linguística (PPGL) at Universidade Federal de Santa Catarina, in the exercise of his legal powers and considering Resolution No. 154/2021/CUN, Resolution No. 04/2021/PROPG, the Bylaws of the Graduate Program in Linguistics, Resolution No. 02/2013/PPGL and the deliberations of the Plenary Board of the PPGL, makes public the period of applications and establishes the rules for carrying out the Selection Exam for the Master's and Doctorate Degree for the semester 2025.1, the area of concentration in Sign Languages, specified below:

1. DATES OF THE SELECTION PROCESS

October 14th to November 7th – Registration period

November 8th to 13th – Validation of the documentation of candidates registered in affirmative actions.

November 14th– Publication of the approval of registrations.

November 15th – Receipt of appeals for review of the approval of registrations.

November 19th – Publication of the final approval of registrations.

November 19th to 25th - Analysis of projects

November 26th to 29th – Publication of the results of the evaluation of projects (eliminatory) on the PPGL website.

December 2nd to 13th – Interview and discussion of the research project in the eliminatory and qualifying stages, held remotely, on a platform to be published on the PPGL website. – Stage II.

December 16th – Publication of the preliminary result.

2. VACANCIES

2.1. The vacancies, approved at a board meeting, are offered according to the availability of the supervising professors.

2.2. Nine vacancies are offered for the Doctorate Course in Linguistics and ten vacancies for the Master's course, totaling 19 vacancies (3 places allocated to the Affirmative Action Policy, distributed as follows: 1 for black, brown, and Indigenous people and 2 for people with disabilities and other categories of social vulnerability, according to Normative Resolution No. 145/2020/CUN of October 27th, 2020).

2.3. The supervisors and their respective vacancies are as follows, distributed in the Area of Concentration in Sign Languages:

2.4. The candidate's project must fit within the research line of the supervisor selected at registration. The supervisor' research lines are described on the website of the Postgraduate Program in Linguistics (<u>http://ppglin.posgrad.ufsc.br/pesquisa/linhas-de-pesquisa/</u>).

2.5. Mandatory courses for the Master's and Doctorate degrees will be offered in Sign Languages, in a hybrid format, in February, July, and August 2025 and 202/6. Preferably, they will be taught in Libras and some of them in IntSL. Interpreters will not be available.

3. REGISTRATION

3.1. Applications for the selection exam for Master's and Doctorate courses to start in 2025.1 will open from **October 14th to November 7th, 2024**.

3.2. Candidates holding a full-time higher education diploma duly recognized by the Brazilian Ministry of Education - Ministério da Educação e Cultura (MEC) may apply. Candidates who have not completed their undergraduate course must present an updated academic transcript at the time of application.

3.3. Candidates with undergraduate diplomas issued abroad must meet the requirements outlined in Resolution 154/2021/CUN and the requirements of Art. 37 of the Program's Bylaws¹.

¹ Article 37 of the regulations of UFSC Postgraduate Program in Linguistics states that: "[...] graduates from undergraduate courses abroad may be admitted, subject to the recognition of the diploma submitted for validation by the delegated Board.

^{§ 1°} The recognition referred to in the caput of this article is intended exclusively for the student's admission to the Program and does not grant national validity to the title.

^{§ 2}º Diplomas from undergraduate courses abroad must be presented with a Brazilian consular visa for authentication, except in cases covered by specific diplomatic agreements."

3.4. Registrations must be made between **October 14th to November 7th, 2024**, exclusively by sending scanned copies of the documents listed in item 1.6 to the following electronic website: <www.capg.ufsc.br/inscricao>

3.5. Application for this selection process will imply knowledge and acceptance of the conditions established in the full content of this Notice and any supplementary notices that may be published.

3.6. For registration, scanned copies of the following documents are required in Portable Document Format (.pdf):

a) Registration form, available on the website <www.capg.ufsc.br/inscricao>, duly completed;

b) Academic transcript and/or undergraduate diploma;

c) Identity card and CPF; foreign candidates must present a passport;

d) 1 (one) 3x4 photo;

e) Research project in PDF format, written in Portuguese, Spanish, or English – without identification of the candidate, or recorded in Libras or International Sign Language;

f) Candidates for the Reserve of Vacancies through the UFSC Affirmative Action Policy must send the documents described in item 3 of this announcement in the same email.

3.7. The documents sent must be in a resolution and format that allows full reading and understanding of their content. In addition to the documents, the candidate must provide the link to the Lattes CV, which must be updated no more than 15 days before the application on the website.

3.8. When applying, the candidate must indicate the position for which they are applying and the supervising professor.

3.9. Applications from candidates whose research projects do not fit into the Program's area of concentration in Sign Languages will not be accepted.

3.10. Each candidate may only apply to one supervisor in the area of concentration in Sign Languages.

3.11. Applications with incomplete documentation, as defined in 1.6 and 1.7, will not be accepted.

3.12. When applying, candidates must indicate whether they wish to present the project in Portuguese, Libras, or International Sign Language.

3.13. Candidates who require accessibility to the indicated texts and/or special conditions to take the test and present their project must provide detailed information about their needs using the form at <www.capg.ufsc.br/inscricao>.

3.14. After the Selection Committee has verified the documentation, only applications that fully comply with this Notice will be approved.

3.15. The approval of registered candidates will be published on the website of the Postgraduate Program in Linguistics by November 7th, 2024.

3.16. Candidates whose registration was not approved may appeal to the Selection Committee, in writing, and with due justification, by email to

<processo.seletivo.ppgl@contato.ufsc.br> within 1 (one) business day from the publication of the
results of the registrations.

3.17. After the appeals are analyzed, the final lists of approved and non-approved registrations will be published on the website of the Postgraduate Program in Linguistics.

3.18. Candidates who opt for affirmative action vacancies must, at the time of registration, indicate in the specific field of the Registration Form whether they wish to compete for affirmative action vacancies in only one of the categories. The respective documentation for each group, to be presented at the time of registration, is described below:

3.18.1 Quotas for Black and Brown people:

3.18.1 The candidate must submit the following documents:

I – Self-declaration that they are Black or Brown, according to the color or race criteria used by the Brazilian Institute of Geography and Statistics Foundation - Instituto Brasileiro de Geografia e Estatística (IBGE) for candidates who select the option of reserving vacancies for Black people (Blacks and Browns) (see APPENDIX A)

3.18.1.1 The validation of the self-declaration of Black or Brown will be carried out by the Black and Brown Self-Declaration Validation Committee, specifically established for this purpose, appointed by the Office of the Vice-Rector for Affirmative Action and Equity - Pró-Reitoria de Ações Afirmativas e Equidade (PROAFE), with the following criteria: those who self-declare as Black or Brown must have phenotypic aspects that characterize them as belonging to the black racial group. According to the Suprema Corte Federal, in the vote on the constitutionality of the Fundamental Precept Noncompliance Action - Arguição de Descumprimento de Preceito Fundamental (ADPF) n. 186, the criterion is the phenotype and not ancestry.

3.18.1.2 The validation process may be carried out in person, by video analysis or through video conferencing systems with video-recorded sessions. The recording may be used in any appeal against the rejection of the self-declaration, and the candidate must state that he/she was the one

who signed the self-declaration as black (black or brown). At the validation process, the candidate must show up in advance and may not be wearing a cap/hood/hood or any other item that hides his/her face, and preferably with his/her hair loose. No other person will be allowed to accompany the candidate.

3.18.1.3 Candidates who have already been approved by the UFSC undergraduate or graduate Black Validation Committees using the phenotypic criterion are exempt from new validation, provided they present proof of previous approval for administrative validation.

3.18.2 **Quotas for Indigenous people**: The candidate selected for the additional vacancies for indigenous people must, at the time of enrollment, prove that he/she belongs to the indigenous people indicated in the application; to this end, he/she must prove his/her indigenous status to the validation committee appointed by the Pro-Rectory of Affirmative Actions and Equity (PROAFE), submitting the following documents:

a) Self-declaration that you are Indigenous - the ethnic group you belong to, the name and municipality of the village, and the state of the federation are contained in Appendix B of this Notice.

b) A Declaration from the chiefdom or other Indigenous representative bodies or a declaration of membership of an Indigenous group signed by a leader.

c) Declaration of Indigenous belonging issued by 3 (three) leaders of the Indigenous Land to which the candidate belongs and Official identification document with photo and signature (front and back) of each of the three leaders who signed the declaration of indigenous belonging (model available at <u>https://validacoes-proafe.ufsc.br/formularios-2/</u>). In case of doubts regarding the recognition of the candidate's indigenous land, entities linked to the defense of indigenous rights may be contacted, preferably FUNAI or similar entities recognized by the validations department.

3.18.2.1 The Indigenous Self-Declaration Validation Committee, particularly established for this purpose and appointed by PROAFE, will validate the Indigenous self-declaration.

3.18.3 Quotas for people with disabilities:

3.18.3.1 Under Lei No. 13,146/15 (Statute of Persons with Disabilities - Estatuto da Pessoa com Deficiência), for this Notice, a person with a disability is someone who has a long-term physical, intellectual, and/or sensory impairment that, in interaction with one or more barriers, may obstruct their full and effective participation in society on an equal basis with other people. This affirmative action also covers people with Autism Spectrum Disorder.

3.18.3.2 Individuals with only aesthetic deformities and/or sensory deficiencies that do not constitute an impediment and/or restriction to their performance in the previous learning process may not apply for vacancies reserved for people with disabilities.

3.18.3.3 Individuals with specific functional disorders (dyslexia, dyscalculia, dysgraphia, attention deficit hyperactivity disorder) may not apply for vacancies reserved for people with disabilities.

3.18.3.4 Eventually, the candidate may be called for an interview by videoconference by the Self-Declaration Validation Committee for Persons with Disabilities.

a) The self-declaration of a person with a disability is in Appendix C.

b) **Medical report**, carried out within the maximum of twelve months before registration for this selection process, must be signed by a doctor who specializes in the candidate's disability, containing, in the clinical description, the degree or level of disability, with express reference to the corresponding code of the International Classification of Diseases (ICD) - Classificação Internacional de Doenças (CID) and description of the impact of the disability on functionality. It must also contain the legible name, stamp, signature, and the professional association number - Conselho Regional de Medicina (CRM) of the doctor who provided the certificate.

c) **Candidates with Hearing Impairment (Deafness)** must present the following exams in addition to the medical report: audiometry (tonal and vocal) and immittance testing, carried out within twelve months before registration for this selection process. The exams must include the professional's legible name, stamp, signature, and CRM.

d) **Candidates with Visual Impairment**, in addition to the medical report, must present an ophthalmological examination stating their visual acuity, carried out no more than twelve months before registration in this selection process, as well as the legible name, stamp, signature, and CRM of the professional who carried out the examination.

e) For candidates with autism, the medical report must include, in addition to the specifications described in item a, information regarding communication, behavior and interpersonal relationships and an indication that the manifestations occurred before the age of 18.

3.18.4 Vacancies for other categories of social vulnerability

3.18.4.1. Vacancy reserved for quilombolas: Candidates selected for the additional vacancies for quilombolas must, at the time of enrollment, prove their status of residence/membership in the

remaining quilombo communities indicated in the application; to this end, they must prove their status as quilombolas to the validation committee appointed by the Pro-Rectory of Affirmative Actions and Equity (PROAFE), submitting the following documents:

a) Self-declaration that you are a quilombola, the name of the quilombola community, municipality, and state of the federation, contained in Appendix E of this Notice.

b) Declaration signed by a recognized quilombola leader, with the respective telephone contact. This declaration must be original, and a copy of the leader's ID, front and back, must be presented to compare the signature's authenticity. The declaration may also be notarized, in which case there is no need to present the leader's ID.

c) Candidates who the UFSC Quilombola Validation Committees have already approved for undergraduate or postgraduate programs are exempt from validation, provided they present proof of previous approval.

3.18.4.1.1 A Self-Declaration Validation Committee will validate the quilombola self-declaration, particularly constituted for this purpose.

3.18.4.2 Vacancies for refugees, asylum seekers, and humanitarian visa holders

I- Self-declaration that you are a refugee, asylum seeker, or victim of other forms of xenophobia, as set out in Appendix F of this Notice.

II- Document proving refugee status recognized by the National Committee for Refugees - Comitê Nacional de Refugiados (CONARE) or competent federal agency; or asylum application protocol; or family reunion visa; or application protocol for extension of the effects of refugee status, by the procedures regulated by Law 9,474/07; or permanent or temporary humanitarian visa issued by the Federal Police.

3.18.4.2.1 When documents proving education are unavailable, the refugee will be allowed to prove it by other means permitted by law, including a certificate provided by CONARE or the competent federal agency, per articles 43 and 44 of Law 9474/1997.

3.18.4.2.2. According to Art. 44, § 4° of Normative Resolution No. 154/2021/CUN, OF OCTOBER 4TH, 2021, "Foreign students in graduate programs must also prove proficiency in Portuguese."

3.18.5.1 A Self-Declaration Validation Committee, particularly established for this purpose, will validate the Trans self-declaration.

4. SELECTION PROCESS

4.1. The selection exam for the Master's and Doctorate degrees will consist of two stages:

(i) Stage I: Blind analysis of the project (eliminatory);

(ii) Stage II: Discussion of each research line's general and specific bibliography and the candidate's project approved in stage I.

4.2. The candidate will be evaluated by a committee consisting of two professors plus the supervisor indicated at the time of registration, to be held according to a specific schedule published on the Program's website during the period of the selection process.

4.3. The selection will be conducted remotely through a digital videoconferencing platform and published on the Program's website.

4.4. The candidate is responsible for the quality of the transmission equipment (computer, cameras) and the connection conditions. Connection failures may result in the candidate's disqualification.

4.5. To be selected, candidates must present an official document with a photo, which must be displayed on the screen, as instructed by the professors who make up the selection committee. Without this document, they cannot participate in the video call.

4.6. The selection will be conducted in Libras or International Sign Language and will cover questions to be answered about the bibliography indicated and the research project submitted at the time of registration.

4.7. Bibliographic materials may not be consulted during the selection process. Participants' cameras must remain on.

4.8. Each candidate will be given a score from zero to ten, based on the average of the scores of each evaluation committee member regarding the questioning of the bibliography.

4.9. Each candidate will be graded from zero to ten based on the average of each evaluation committee member's grades regarding the research project and its relationship with the line of research and the intended area of concentration.

4.10. The candidate's final grade will be determined by averaging the bibliography grades and the research project.

4.11. The minimum final grade for approval is 7 (seven).

4.12. In the event of a tie, the CV of the candidate that best fits the intended line of research will be considered.

4.14. The research project must be submitted in PDF format. The text must be between 10 and 20 pages long, in A4 paper format, with 1.5 line spacing, margins no smaller than 2.5 cm, Times New Roman font size 12, and must include the candidate's identification. The maximum file size must be 5Mb. If submitted in Libras or International Sign Language, the project must be between 15 and 20 minutes long and made available via a YouTube link in an unlisted format. The YouTube link must be provided on the electronic application form. It is recommended that the research project contain the following information:

- a) Title (and, optionally, subtitle);
- b) Indication of the intended advisor in the area of concentration in Sign Languages;
- c) Abstract and keywords;
- d) Introduction (contextualization, justification, problem, objectives);
- e) Method;
- f) Theoretical framework;
- g) Expected results;
- h) Research execution schedule;
- i) Bibliographical references.

4.15. The discussion will be conducted via a digital videoconferencing platform, with a committee formed by professors from the Program (preferably including the advisor) and the candidate). The link for the discussion will be sent by the Program secretariat directly to the candidate. This stage will be recorded. The discussion will last between 20 and 40 minutes. The stipulated time will follow Brasília time.

4.16. Suppose the connection to the online platform for the discussion is problematic. In that case,

the advisor will reschedule the discussion for another time, maintaining the composition of the committee and procedures described in 4.17 and respecting the period for the discussion.

4.17. The discussion will take into account the following criteria:

a) cohesion and coherence in the presentation and articulation of ideas;

b) ability to synthesize, critically reason, and argue;

c) mastery of the proposed theme and theoretical knowledge;

d) theoretical and methodological consistency of the argument in linguistic studies related to the candidate's line of research.

4. 18. After analyzing and arguing the project, the evaluators will write minutes of the process, which will be forwarded to the selection committee.

4. 19. The final classification of the approved candidates will be based on the grade obtained in the written test. This classification will not be used as the sole criterion for the order of the waiting list for the Program's scholarships. Another classification model will be adopted later and published in a specific notice for scholarship purposes.

5. APPEALS

5.1. Candidates may appeal the selection process results within 1 (one) business day after the publication of the results on the Program website. 6. CLASSIFICATIONS IN AFFIRMATIVE ACTIONS

6.1 For classification purposes, two lists of candidates will be created in descending order according to the final score.
