*On the rules of the selection process for new  
Doctoral students in the Graduate Program in  
Linguistics at UFSC.*

The Coordinator of the Graduate Program in Linguistics at the Universidade Federal de Santa Catarina (PPGL), in the exercise of his statutory duties and considering Resolution No. 95 / CUN / UFSC / 2017, the Bylaws of the Graduate Program in Linguistics (PPGL) 2018, Resolution No. 2 / PPGL / 2013 and the deliberations of the Collegiate Board of the Program, **makes public the call for applications and establishes rules for carrying out the Selection Exam for the Doctoral Program, semester 2020.1**, specified below:

## **1. APPLICATIONS**

1.1 From 15 August to 30 September 2019, applications are open for the selection exam for the Doctoral program, 2020.1 entrance.

1.2 Applicants who have completed higher education in full-length regime, duly recognized by the Brazilian Ministry of Education, are eligible to apply.

1.3 Applicants who have not completed an undergraduate program must submit updated transcripts. If approved in the exam, they must prove completion of the undergraduate program upon the first enrolment.

1.4 Applicants with undergraduate diplomas issued abroad must meet the requirements set out in Resolution 95/CUn/2017 and the requirements of Art. 37 of the Bylaws of the Program<sup>1</sup>.

1.5 Applications must be carried out, from 15 August 2019 to 30 September 2019, **exclusively** by sending scanned copies of the documents listed in item 1.7 to the following

<sup>1</sup>Article 37 of the bylaws of the Graduate Program in Linguistics at UFSC states that: “[...] those graduated in courses abroad may be admitted through the recognition of their diploma, submitted to validation by the commissioned Collegiate.

Paragraph 1. The appraisal referred to in the caput of this article is to be used solely for the student's admission to the program, not giving national validity to the title.

Paragraph 2. The diplomas of undergraduate programs abroad must be presented with a Brazilian consular authentication visa, except in cases supported by specific diplomatic agreements. ”

1.6 Application in this selection process will imply knowledge and tacit acceptance of the conditions set forth in the entire contents of this Notice, as well as any additional notices that may be published.

1.7 Application requires digitized copies of the following documents in *Portable Document Format* (.pdf):

- a) Application form duly completed on the website < [www.capg.ufsc.br/inscricao](http://www.capg.ufsc.br/inscricao) > (not available in English);
- b) Transcripts and undergraduate diploma;
- c) Identity Card and CPF; foreign applicants must present passport and visa;
- d) 1 (one) 3x4 photo;
- e) A written version of the research proposal, written or recorded in Libras (Brazilian sign language).

1.8 Submitted documents must be in resolution and format that allow for clear reading and understanding of their content, and as a **single file** in *Portable Document Format* (.pdf). **It is mandatory** that the applicant submits the documents listed in item 1.7 in a numbered and organized manner. In addition to the documents, in the body of the email, the applicant should provide their Lattes Curriculum link, last updated in August 2019 or later.

1.9. Upon registration, applicants must inform the vacancies to which they are applying, indicating the **Line of Research line** and the **advising professors**.

1.10. Applications will not be accepted from candidates whose research proposals do not fit the Program's lines of research in which the vacancies are offered.

1.11. Applications with incomplete documentation will not be accepted.

1.12. Upon application, deaf applicants must write in the body of the email if they wish to take the written test in Portuguese or in Libras.

Sole Paragraph: To take the test in Libras, applicants will use webcam-equipped computers and the *Movie Maker* program. Basic instructions on how to use the program will be given on the day of the test, but it is recommended that deaf applicants who choose this type of assessment be familiar with video recording and editing procedures through this program.

1.13. Applicants who require special conditions to take the exam must notify the Programs' Office by e-mail upon registration.

1.14. Only entries that fully comply with this Notice will be homologated, after verification of the documentation by the Selection Committee.

1.15. The homologation of the applications will be published on the website of the Graduate Program in Linguistics and / or on the notice board of the Programs' Office **until October 15, 2019**.

1.16. Applicants with non-homologated applications may appeal to the Selection Committee in writing, and duly justified, within 24 (twenty-four) hours after the application results have been published.

1.17. After the analysis of the appeals, the definitive lists of homologated and non-homologated applications will be published on the website of the Graduate Program in Linguistics and / or on the notice board of the Programs' Office.

## **2. VACANCIES**

2.1 The vacancies, approved at a Collegiate Board meeting, are offered according to the availability of the advising professors.

2.2 **29 vacancies** are offered for the Doctoral Program in Linguistics.

2.4 Applicants' proposals must fit the line of research of the advisor selected upon application. The description of the advising professors' lines of research can be found on the website of the Graduate Program in Linguistics (<http://ppglin.posgrad.ufsc.br/concentrations/>).

### **3. RESERVATION OF VACANCIES**

3.1 Twenty percent (20%) of the vacancies offered are reserved to the Ethnic-Racial Quota System, and ten percent (10%) to the Disability Quota System.

3.2 In addition to the requirements regarding application in general, applicants who wish to compete in the Ethnic-Racial Quota System or the Disability Quota System must expressly state their intention upon application via email.

3.3 Based on the application of item VIII of Article 37 of the Brazilian Federal Constitution and, by similitude, with paragraph 2 of Article 5 of Law No. 8,112 / 1990 in conjunction with Decree No. 3,298 / 1999, there will be a 10% (ten per cent) reservation for applicants with disabilities, pursuant to this Notice.

3.4 Applicants with unilateral hearing loss do not qualify as persons with disabilities for the purpose of applying for the reserved vacancies provided for in item 3.1, according to STJ Precedent No. 552/2015.

3.5 Upon registration, applicants with disabilities shall inform, in the provisional application request, about the type of disability they have and attach a medical report to the application, in addition to the documents requested in item 1.7. The medical report shall

attest the type and degree or level of disability, with express reference to the corresponding International Classification of Diseases (ICD) code. The report must include the identification and signature of the reporting doctor.

3.6 The applicant who does not prove the disability informed by means of the medical report attached to the application shall not compete for a vacancy reserved for persons with disabilities, competing only for ample competition vacancies.

3.7 Based on the application of Normative Resolution No. 52 / CUn / 2015 of June 16, 2015 (republished with changes promoted by Resolution No. 22 / CUn of September 8, 2015), there will be a reservation of 20% (twenty percent) of the Doctoral program vacancies for people of Brazilian nationality belonging to the self-declared black, brown and indigenous segments, pursuant to this Notice.

3.8 The applicant shall, upon registration via email, make the ethnic-racial self-declaration.

3.9 The applicants will not be heteroidentified as a selection phase. Indications of irregularities, on the other hand, will be reported to the PPGL Collegiate Board for verification as per its regulations.

3.10. Approved applicants whose exam performances are ranked within the number of vacancies offered for the ample competition will not be counted for the purpose of filling the reserved vacancies.

3.11. In the event of withdrawal of an applicant approved in a reserved vacancy, the vacancy will be filled by an applicant who requested inclusion via the Quota System and is classified in the immediately subsequent position.

3.12. In the event that there are not enough approved applicants to fill the reserved vacancies, the remaining vacancies will be reverted to the ample competition.

3.13 Applicants registered in the Quota System upon application will concurrently compete for reserved and ample competition vacancies, according to their rank in the selection exam.

#### **4. SELECTION PROCESS**

4.1 The Doctoral program selection exam will consist of two steps:

1) **written test in Portuguese**, of an eliminatory and classificatory nature, in the case of hearing applicants; and **filmed test in Libras**, also of an eliminatory and classificatory nature, in the case of deaf applicants.

2) **proposal analysis**, of an eliminatory nature.

4.2 To take the tests, the applicants must present a photo identification document, without which they will not be able to take the tests.

4.3 The **written test** in Portuguese or **filmed in Libras** is composed of discursive questions about the language field and is elaborated based on the indicated bibliography.

4.4 The written test consists of **two questions: the first question is of a general nature; the second question is specific, unique to the Line of Research chosen by the applicant**. Each question will correspond to 50% of the total of the test. Applicants should show that they are able to solve linguistic problems and / or discuss issues pertaining to the language field.

4.5 Applicants should answer both general and the specific questions. The specific question corresponds to the Line of Research to which the applicant has applied. Answers to questions pertaining to Lines of Research other than the one chosen upon application will not be marked.

4.6 Each of the questions on the test will be marked by two evaluators. The final grade of the question will be the result of the sum and division of the two grades awarded by the two evaluators. The final grade of the test results from the sum of the final grades of each of the questions. In the event of a discrepancy between the two assessments, the test will be marked by a third evaluator, who will award the final grade based on his / her assessment and the preceding assessments.

4.7 The tests will be graded from zero to ten. The minimum passing grade is 7 (seven).

4.8 Written and filmed tests are not identified by the evaluators and therefore cannot be signed by the applicant. Each test will be assigned a code by the selection committee. At the end of the assessment, after the final grade is awarded, the applicants' tests will be identified by the committee.

4.9 The written or filmed test is eliminatory and classificatory. Only the applicants approved in the first stage shall participate in the proposal analysis stage.

4.14. The **project analysis**, which makes up the second stage of the selection exam, will be carried out by 2 (two) professors of the Program, designated by the Selection Committee, one of whom must be the advisor chosen by the applicant.

4.15. The project must contain a minimum of 10 pages and a maximum of 20 pages. The proposal analysis will assess:

- a) relevance of the proposal to the line of research applied;
- b) definition of the problem / research question to be investigated;
- c) objectives and research hypotheses / assumptions;
- d) consistent theoretical framework;
- e) methodology;
- f) bibliography.

4.18. The proposals will be assessed as **approved** or **not approved**.

4.19. After the defense, the evaluators will issue minutes of the proposal analysis process, which will be forwarded to the selection committee.

4.20. The final ranking of the approved applicants will be based on the grades obtained in the written test.

## **5. SELECTION EXAM DATES**

5.1 The selection exam will be held from **October 30** to **November 08** of **2019**, according to the schedule below:

**October 30, 2019** - Written test | filmed in Libras (eliminary and classificatory): from 2 pm to 6 pm, at UFSC's School of Communication and Expression - CCE, in a place to be published on PPGL's website.

**November 05 and 06, 2019** - Proposal Analysis.

5.2 The final results of the selection exam will be published on the Program's website after it is homologated by the Collegiate Board.

## **6. APPEALS**

6.1 Applicants may appeal against the result of each of the two eliminatory stages of the selection process, within 24 (twenty-four) hours after the publication of the result of that

stage on the Program's notice board or website. The date of protocol with the Program's office will be considered for the deadline.

6.2 Appeals must be personally submitted at the Program's office or emailed to <[processo.seletivo.ppgl@contato.ufsc.br](mailto:processo.seletivo.ppgl@contato.ufsc.br)> containing the applicant's full name, explanatory memorandum and theoretical basis for the request for review. In the field subject, the expression DOCTORAL APPEAL - NAME OF APPLICANT must be included.

6.3 Appeals that do not meet the provisions set forth herein will be rejected.

6.4 The Selection Committee is the only instance for appeal and is sovereign in its decisions, therefore there shall be no other further appeals.

Paragraph 1. The Selection Committee will issue an opinion within 24 (twenty-four) hours after the end of the appeal period.

Paragraph 2. The opinion will be made available for consultation at the Program's office or emailed as appropriate.

## **7. FINAL PROVISIONS**

7.1 At any time, and at the discretion of the Selection Committee, if the documents and / or signatures presented are ascertained as disreputable or illegitimate, the application will be considered canceled.

7.2. Upon first enrollment in the Program, applicants approved in the selection exam will be called to the Program's office to submit the following documents:

- a) 3x4 photo (recent);
- b) Certified copy of transcript;
- c) Certified copy of undergraduate diploma;
- d) Certified copy of Identity Card and CPF (Brazil's Taxpayer Registration Number);
- e) Passport and visa (only for foreign applicants).
